INVITATION TO PREQUALIFICATION

Name of Project : **Hanthawaddy International Airport Project**

The Department of Civil Aviation, Ministry of Transport, will accept submissions for pre-qualification from Prime Contractors interested in bidding on the Hanthawaddy International Airport Project (hereinafter referred to as the "Project") at a location 48 miles north-east of Yangon City in Bago Region, Myanmar. The Prime Contractors may form consortia of related engineering disciplines in which case the executed consortium agreement is to be included in the prequalification documents. The prequalification procedure will be as follows:

1. The Department of Civil Aviation, Ministry of Transport, intends to prequalify international firms or consortia in collaboration with local contractors for construction of the Hanthawaddy International Airport and its related airport facilities in accordance with international standards and best practices.
2. The main scope of works for the Project will include:
 - (i) Master planning including design criteria;
 - (ii) Preliminary and detailed design;
 - (iii) Construction of Control Tower and Operation Building, Terminal Building(s), Runway, Taxiway, Apron and Drainage System;
 - (iv) Installation of Communication, Navigation and Surveillance (CNS) System, Airfield Lighting System;
 - (v) Fire Fighting Building & Facilities;
 - (vi) Water Supply and Sewage Treatment System;
 - (vii) Electrical Power Supply and Distribution System;
 - (viii) Fuel Storage and Distribution System including fuel hydrant system;
 - (ix) Security System;
 - (x) Environmental Impact Study (EIS);
 - (xi) Social and Cultural Impact Study (SIS, CIS);
 - (xii) Construction of road and rail access and car parking;
 - (xiii) Construction of cargo facilities, hotel and other ancillary infrastructure;
 - (xiv) Management, Operation and Maintenance of the Airport;

3. It is expected that the prequalified firms/consortia will be invited to submit bids for the Project in October, 2012.
4. The Project will be implemented through Public Private Partnership (PPP), Joint Venture or Build Operate Transfer (BOT), in accordance with the Myanmar Foreign Investment Law.
5. The Prequalification Documents in the English language may be purchased by interested firms on the submission of written application and evidence of payment of a non-refundable fee of US\$ 1,000 by means of bank transfer to:
